1. **INDEPENDENT MEMBER.** Subject to the approval of IMPaX WORLD, INC., a California corporation ("Company") I agree to become an independent Member for the Company. I am an adult.
2. **ACKNOWLEDGEMENT AND AGREEMENT.** I agree:
 - a. **BEST EFFORTS TO SELL COMPANY SERVICES AND PRODUCTS.** To use my best efforts to sell the Company's services and products and abide by the terms of the Company's Business Guide and other Company policies and procedures, as amended by the Company from time to time ("Guide"). I acknowledge that I have obtained a copy of the Guide from the Company's website or have requested a copy from the Company by mail.

6. **EFFECTIVE DATE; TERM.** I agree that this Agreement shall be effective when accepted by the Company and shall, unless terminated by me or the Company, remain in full force so long as I pay the annual renewal fees and comply with the Guide.
7. **GOVERNING LAW; VENUE.** I agree that this Agreement shall be governed by California law and any action to enforce or interpret its terms shall be brought in El Dorado County, California.
